## MEMORANDUM:

PART 2: Mental Health Screenings Made Conditional Civil Rights, Constitutional Rights, and Civil Honors

Be it known by all persons, "This day the Supreme Court of the United States has made a unanimous ruling 9-0 in *Caligna v Strom* whereby the formal policies prior set forth by RACCOON TECHNOLOGIES INCORPORATED are so affirmed and upheld against UNCONSTITUTIONAL SEARCH AND SEIZURE, HARASSMENT AT WORK OR IN PUBLIC FOR PRIVATE PROPERTY RIGHTS OR THEIR FREE EXERCISE, and against UNLAWFUL SEARCH AND SEIZURE in part or sole act before any agent of the UNITED STATES or its commissioned CORPORATIONS."

RACCOON TECHNOLOGIES INCORPORATED agrees with this decision, themed settled law and affirms its continued prior policy against such unlawful threat or abuse of public welfare claims as used in the kidnapping and 2001-2021 concealment to blackmail and extort persons in PETERSEN v ALLEN and FR-18-04, a qui tam (31 U.S.C. 3729(a) violation so alleged also felony embezzlement themed 18 USC 666 violation under present complaint to the U.S. Attorney General of the United States.

Be ye so advised, these matters are subject ZERO TOLERANCE, and their violation will result in IMMEDIATE TERMINATION of any employee or contractor, or ORDER TO LEAVE THE PROPERTY AND PLACE OF WORK by any vendor or customer or other person not on official business of the UNITED STATES or government organization or agency.

Use of mental health fraud to falsely portray victims of criminal and political crimes themed GENOCIDE and other forms of abuse of ordinary civil procedure barred by 5 USC, 15 USC, 18 USC, and 42 USC are subject immediate and permanent sanctions by RACCOON TECHNOLOGIES INCORPORATED.

Employees and customers will conduct themselves accordingly or voluntarily cease all benefits and void any deliverable property without waiver of payment or fee fully earned for violation of this condition against acts constructive to "THE WAR CRIME GENOCIDE" or any oral or other communication in support of such fraud.

RACCOON TECHNOLOGIES INCORPORATED stands by the right of 76 O.S. 76-1 (inherent rights) and 76-6 (reputation) in this protection, and use of this fraud to chill the lawful "hue and cry" of any victim of persons engaged in a pattern of fraud and violence will be themed "racketeering" by all participants and subject application of the Oklahoma RIOT ACT on sustained resistance.

Fraud in this matter is presently under formal criminal complaint, and themed a foreign sponsored domestically supported activity violating the Oklahoma Anti Terrorism Act.

This will be your only warning prior sanctions and lawful activity to restore civil order.
